Candidates who have opted for the classes require a **minimum of 75% attendance** to be eligible to appear for the examinations.

For members and students who have not yet produced their original certificates or duly attested copies in regard to their date of birth and educational qualifications along with the experience certificate, in original, from their employers are requested to please do so immediately. Non production of the said documents may lead to rejection of the examination application form.

For all subjects – 1 st /IInd yr PGDSM & Associateship / Fellowship	:	Rs.5000/-
For 4 subjects – 1 st /IInd yr PGDSM & Associateship / Fellowship (For repeaters only)	:	Rs.4000/-
For 3 subjects – 1 st /IInd yr PGDSM & Associateship / Fellowship (For repeaters only)	:	Rs.3000/-
For 2 subjects – 1 st / IInd yr PGDSM & Associateship / Fellowship (For repeaters only)	:	Rs.2000/-
For 1 subject – 1 st / IInd yr PGDSM & Associateship / Fellowship (For repeaters only)	:	Rs.1000/-

(NOTE: Students appearing for 1st year or 2nd (Final) year examination first time, need to pay Rs.5000/- irrespective of number of papers they are appearing).

The students, those who are appearing for Associateship or Fellowship examinations, are requested to pay Rs.1000/- extra towards their membership subscription for 2017-18, if not paid.


