The next Associateship, Fellowship and Post Graduate Diploma in Shipping Management & Logistics Examinations are to be held in March 2021. The Institute proposes to hold the examinations simultaneously at Mumbai and Gandhidham. The Institute also proposes to hold the examinations simultaneously at Ahmedabad, New Delhi, Kolkata, Vizag, Chennai, Kochi and Goa if the candidates are more than ten. As such, candidates who have given the option for Ahmedabad, New Delhi, Kolkata, Vizag, Chennai, Kochi and Goa should give the second option of either Mumbai or Gandhidham. In case it is not feasible to hold the exams in present pandemic situation, on line examination will be conducted.

Candidates registered for the correspondence courses may please ensure that they submit to the Institute the Model Test Papers (assignments) duly answered prior to 31st December, 2020 either through courier or through e-mail. Non-submission of at least 2 of the Model Test Papers, duly answered, may result in rejection of their examination application form.

Candidates, who have opted for the regular course by attending the classes, require a **minimum of 75% attendance** to be eligible to appear for the examinations. Attendance short of 75% attendance may result in rejection of their examination form.

For members and students who have not yet submitted duly attested copies of their birth certificate, educational qualifications and experience certificate in original from their employers, are requested to please do so immediately. Non-submission of the said documents may result in rejection of the exam application.

The students/candidates, who are yet to pay the balance course fees, are required to pay the same before 31st December 2020. Otherwise, these students will not be allowed to fill up exam form and will not be permitted to appear for exam.

The examination form can be downloaded from our website (which will be uploaded on 01.01.2021). This is to be submitted along with examination fee, subscription or arrears, if any on or before 31st January, 2021. It is mandatory to complete full details as required in the examination form.

For all subjects – IInd yr PGDSM&L & Fellowship : Rs. 5000/-

For 4 subjects – 1st/IInd yr PGDSM&L & Associateship / :Rs. 4000/-

For 3 subjects – 1st/IInd yr PGDSM&L & Associateship / :Rs. 3000/-

Fellowship (For repeaters only)

For 2 subjects – 1st / IInd yr PGDSM&L & Associateship / :Rs. 2000/-

Fellowship (For repeaters only)

For 1 subject – 1st / IInd yr PGDSM&L & Associateship / : Rs. 1000/-

Fellowship (For repeaters only)

Examination Late Fee (No application Would be entertained beyond 05.02.2021)

(NOTE: Students appearing for 1st year examination <u>first time</u>, need to pay Rs. 5000/-irrespective of number of papers they are appearing).

(NOTE: Students appearing for IInd year examination <u>first time</u>, (registered for FINAL YEAR before 31st March 2020) need to pay Rs. 6000/- irrespective of number of papers they are appearing).

(NOTE: the students who are enrolled for the First year from 1.4. 2020 onwards, have to pay the examination fee and 18% GST on it.)

The students, those who are appearing for Associateship or Fellowship examinations, are requested to pay Rs.1000/- extra towards their membership subscription for 2020-21, if not paid.

The above fees can be paid 'online' either through internet banking or through credit/debit card, while filling up examination form which will be available on our website www.nmis.net from 01.01.2021. Alternatively, the fees can be paid through demand draft, favoring 'NAROTTAM MORARJEE INSTITUTE OF SHIPPING", payable at Mumbai before 31st January 2021.

Application for March 2021 examination can be made on line through NMIS website. Last, date for filling up application for March 2021 examination is **31.01.2021**.

Please also upload your recent photograph whilst filling the online examination application.

Please use the same login id of admission or contact to Institute for login ID.

Hall ticket will be made available online before the examination. Students are requested to take out the print and bring the same while appearing for papers.

The March 2021 examination will be held on 6^{th} , 7^{th} , 13^{th} , 14^{th} and 21^{st} March 2021 for First year.

The March 2021 examination will be held on 6^{th} , 7^{th} , 13^{th} , 14^{th} , 20^{th} and 21^{st} March 2021 for Final year. The detailed examination timetable is attached below.
