Rail is one of the efficient way of transporting bulky goods like ore, coal. It is also less time consuming and favourable for both ~~and~~ short & long distances.


#### 3. Airway :

And due to which it incurs loss of Sale.


So it will not work like that and you will need to have a proper distribution channel so that your product can reach the consumers easily and efficiently. There are two types of distribution Channel.

- 1. Consumer distribution channel
- 2. Industrial distribution channel.

The industrial distribution channel is smaller than of consumer channel as the industrial channel mostly has direct relation with consumers or close relation with the user.

Consumer distribution channel has to undergo through various people as there are a lot of people involve due to which direct channel may not be feasible for the manufacturer or supplier.

## Consumer Industrial Channel.



### 1. Manufacturer to Consumer:

The first case is manufacturer directly providing goods to his consumer without mediator in between. This is also cost saving and simple method.

### 2. Manufacturer to Wholesaler to Consumer:

In this type, the manufacturer gives its goods or sells its to manufacturer in bulk & then the wholesale ~~then~~ sells it the consumer maybe at less than retail price, as he has received it in bulk from manufacturer and in view of that he also would have received it at economical price. This is the reason why wholesale price is lesser than retail price.

### 3. Manufacturer to Wholesaler to Retailer to Consumer:

The goods from manufacturer goes to wholesaler first and the wholesaler then sells it to retailer. The retailers take the minimum quantity of goods as maybe he do not have much storage space or area to store the goods. And the retailer then sells it off to the final consumer.

4. Manufacturer to agent to wholesaler to retailer to consumer:

There's a Sales team who works and looks for the vendor of goods. And gets commission for the same. This agent makes the communication with the wholesaler and the manufacturer. And as per this the goods flow from manufacturer to the agent who communicated, to wholesaler, then wholesaler then sell the goods to retailer and it final reaches to the end consumer.

### Industrial distribution channel

→ Manufacturer to Industrial consumer

→ Manufacturer to wholesaler to consumer

→ Manufacturer to agent to Industrial consumer.

## LEARNING - 4

1. Manufacturer to Industrial consumer:

As there is bulk of cargo and due to the close relations with consumer the goods or cargo or product goes from manufacturer to the industrial consumer. The goods being traded in this channel would be fixed assets or capital equipments or goods.

2. Manufacturer to wholesaler to consumer:

The goods from manufacturer sold to wholesaler who then provides it to the industrial consumer.

3. Manufacturer to agent to Consumer:

The goods are given to the agent from the manufacturer to save the cost, he then gives it to the industrial consumer.

Let's understand this distribution channel with example:

One company is there producing tyre & ensuring the safety of it, that it will not get break or puncture if ever it gets into worse road condition.

Now he has to increase his trade in international market also and his users are usually are the police, ambulances, fire fighters, or general public.

So now, to sell it to government there he cannot directly contact the government of there & so he hires agent over there who ensure the safety of fire for government. So this is the indirect distribution of goods.

And on the other hand, if the general public takes 4 to 5 units daily, it will be not practical for him to attend the individually so he sells the unit types to retailers for selling to it to end users. This is the direct distribution to the general public.
